

TERMS OF SERVICE

OVERVIEW

1. This website is operated by The Jewish Welfare Board Singapore. Throughout the site, the terms “we”, “us” and “our” refer to The Jewish Welfare Board Singapore. The Jewish Welfare Board Singapore offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
2.
